## Stronger Super—Choice Fund Election

### **About this form**

Under the Stronger Super legislation reforms, the Government will require all mandated employer superannuation contributions to be paid to a MySuper product from 1 January 2014, and most existing superannuation balances to be transferred to a MySuper product by 1 July 2017—unless you choose otherwise in writing.

**If you want your superannuation contributions to continue to be made to the Manildra Flour Mills Retirement Fund and your benefits to remain in the Manildra Flour Mills Retirement Fund after 1 January 2014, you must return this form signed and dated, to the Fund Secretary by 31 July 2013.**

**Warning:** If you do not return this form (or choose another fund), from 1 January 2014 your mandated employer contributions will be paid to a MySuper fund which will be selected by the Manildra Group and your existing balance in the Fund will be transferred to a MySuper fund at some time between that date and 1 July 2017. Once this happens, you will cease to be a member of the Fund and all insurance cover provided in the Fund for you will cease.
